BODHI WARRANTY POLICY

Software Development, LLC's (hereinafter "Bodhi") Hardware Product(s) are warranted to be free from defects in manufacture for a period of two (2) years after the date of purchase from Bodhi or an authorized Bodhi dealer, under the terms and conditions set forth below. This warranty is contingent upon the installation of the Bodhi Hardware Product(s) by Bodhi trained technicians. This warranty is also contingent upon the Buyer and/or Buyer's representative's strict adherence to all of Bodhi's published material and system design specifications. Bodhi relies on Buyer or Buyer's representative's engineering to ensure all design assessments were performed, defined and disclosed and that the selection of Bodhi Hardware Product(s) was within those engineering parameters. Failure(s) which have been caused by installations outside the Bodhi Hardware Product(s)' design limitations shall not be eligible for warranty coverage nor shall Bodhi be held liable for damages relating to the failure of an improperly selected or installed Bodhi Hardware Product(s).

CLAIMS

1.1 In the event that a failure due to defect is suspected within the Warranty Period, the buyer must notify Bodhi of the suspected defect by email at the address below within twenty four (24) hours of discovery and provide the requested information. Bodhi will be given the right to investigate in an attempt to determine the cause of the claimed condition, after which Bodhi will propose corrective action if appropriate. In the event that a defect is found in the Bodhi Hardware Product at issue, Bodhi shall pay shipping for the return and the replacement of the defective product with the same product or the most similar product available. In emergency cases, Bodhi may offer a replacement product prior to its receipt of the defective product, so long as it is guaranteed to receive the defective product within thirty (30) days. If Bodhi does not receive the defective product within thirty (30) days, or upon return the product is found to have an issue that is not covered by this warranty, Bodhi shall charge buyer the full cost of the replacement, plus shipping charges incurred. Bodhi's maximum monetary liability pursuant to this warranty is expressly limited to the purchase price of the Bodhi Hardware Product(s) which failed. Buyer shall not return any product to Bodhi without prior authorization from Bodhi.

1. LIMITED WARRANTY

2.1 This warranty is the only warranty Bodhi makes with respect to Bodhi Hardware Product(s), and no other warranties are made to Buyer. Bodhi neither assumes nor authorizes anyone to assume for it any other obligation or liability (or to make or give any warranty) in connection with Bodhi Hardware Products. Unless otherwise required by law, Bodhi's sole obligation under the limited warranty, and Buyer's exclusive remedy with respect thereto, shall be, in Bodhi's sole discretion, to replace the subject product, or to reimburse the purchase price thereof to Buyer.

2.2 Bodhi shall have no liability for incidental or consequential damages or reparations in any amount other than as expressly set forth above, and all other liability of any type is hereby expressly disclaimed. Bodhi's liability for any claim of any kind, including claims based upon strict liability, for injury, loss or damage of any nature arising out of, connected with, or arising from the use of the Bodhi Hardware Product(s), shall in no case exceed the purchase price allocable to the Bodhi Hardware Product(s) upon which the alleged claim is based. The failure of the Buyer to give timely written notice as described above shall bar any claim for such failure under this warranty.

2.3 EXCEPT AS EXPRESSLY SET FORTH ABOVE, BODHI MAKES NO WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, WITH RESPECT TO THE PRODUCTS. BODHI HEREBY SPECIFICALLY DISCLAIMS ALL OTHER EXPRESS, STATUTORY, AND IMPLIED WARRANTIES AND CONDITIONS, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, AND THE IMPLIED CONDITION OF SATISFACTORY QUALITY. EXCEPT AS EXPRESSLY STATED HEREIN, ALL PRODUCTS ARE SUPPLIED ON AN "AS IS" BASIS WITHOUT WARRANTY.
